 - (a) "The said Proposal contained in the paper writing marked as Schedule "A" annexed hereto, (including the settlements, compromises, arrangements, reorganizations,

corporate transaction and releases set out therein) be and is hereby approved pursuant to the provisions of the BIA and, as at the Implementation Date (defined therein), will be effective and will enure to the benefit of and be binding upon Newgen and all other Persons (defined therein) named or referred to therein or in the Approval Order (defined therein)."

- 2. The Order pronounced Monday March 9, 2014, be amended by adding the following paragraphs after Paragraph 1:
 - "2. The Proposal Trustee is hereby authorized and directed to take all actions and steps necessary or appropriate to implement and complete the Proposal including making all payments and distributions required to be made pursuant to the Proposal.
 - 3. The releases contemplated by Section 6.3 of the Proposal be and are hereby confirmed.
 - 4. The bankruptcy of Newgen shall be annulled as of, but not before, the Annulment Date (as defined in the Proposal).
 - 5. Any transfers, assignments or other conveyances in respect of the Proposal to be registered at any Land Title Office or any other government agency shall be deemed to be validly executed if signed in the following manner:

requested to make such orders and to provide such assistance to the Proposal Trustee, as an officer of this Court, as may be necessary or desirable to give effect to this Order, to grant representative status to the Proposal Trustee in any foreign proceeding, or to assist the Proposal Trustee and its agents in carrying out the terms of this Order."
